We would like to take this opportunity to invite you to the Grand Pacific Tournament and the PITA State Shoots in AK, AZ, HI, CO, WA, OR, ID, NV, CA, and NY . As you are aware, the requirements by the BATF for the entry into the U.S. sometimes requires a personal invitation to a shooting event. The purpose of this letter is a personal invitation to you to attend our State Shoots and the Grand Pacific Tournament as well as the other shoots in the U.S.

The 93th annual Grand Pacific Trapshooting Tournament hosted by the PITA is scheduled for July 20-26, 2025. This year the Grand Pacific will be held this year at Bend Trap Club in Bend, Oregon.

A program of events required for your border crossing will be available in May, 2025. You can obtain a copy from Marshall Wirawan, BCTA Secretary or you may download the program from the PITA's website (www.shootpita.com).

PITA affiliated clubs host many shoots throughout the year, and we encourage you to attend as many as you can. The programs for many of these are available on our website or you can contact the clubs directly.

Per US federal guidance, the PITA recommends shooters visiting from Canada to the United States consult US CDC regulations and recommendations regarding COVID-19 protocols for all aspects of travel prior to making arrangements. In addition to these measures, the PITA also recommends shooters from Canada consult state and local COVID-19 regulations and restrictions for travel, lodging, etc. once entering the United States prior to making arrangements.

The required BATF form 6NIA may be obtained from the ATF website that can be accessed at <https://shootpita.com/pita-forms/>. You should submit the form well in advance of your planned travel to the U.S.
